**Abstract** Bert Hodge Hill, the director of the American School of Classical Studies at Athens from 1906 to 1926, was also involved in relief work in Greece, beginning with the American Red Cross mission in 1918–1919 and continuing until 1927–1928, when he served as a substitute member of the Refugee Settlement Commission. Throughout this period Hill built and maintained an extensive social network that helped to promote the interests of the School. His work yielded substantial benefits for the institution on several occasions, particularly when there was a need to expropriate land for the Gennadius Library and to negotiate with the Greek government during the initial stages of the Athenian Agora project.

**Abstract** Given the overwhelming scholarly attention directed towards the Old and New Perspectives within the Pauline Studies guild, much worthwhile Pauline scholarship continues to float beneath or beyond our interpretive radar. Recent post-colonial, ecotheological and philosophical reappraisals of Paul are changing the way we do business—with some interesting alternative conclusions. As a ‘state of play’ synopsis, this article seeks to summarize ways in which alternative discourses like (1) continental philosophy, (2) ecological hermeneutics, (3) post-colonial/gender reconstructions, and (4) social-scientific theory can shed a necessary, nuanced light on Paul and his continued relevance beyond the duelling perspectives. **Abstract** Between research on conversion / recruitment of the individual and the study of the expansion of the early church lies an area of research which has not been widely examined: group founding, where founding is seen as the actual coalescence of a group and not, for example, the development of group identity in an already established group. The meaning of these sections is in question from the perspective of Corinthian scholars. Several believe that Paul is appealing to apostolic power and authority to coerce the Corinthians to obey him, whereas others find him responding to social situations. This is different from the way that imitation and discipleship are presented within the writings of Ignatius of Antioch. Pauline ideas, specifically those from 1 Corinthians, are known to have influenced Ignatius of Antioch's writing, and thus Ignatius' ideas about imitation are likely to reflect the meaning that Paul intended. Ignatius specifically speaks about imitation and discipleship in several places: Ign. Eph. 1, 2, 4; 3:1-3, Ign. Magn. 4:1; 5:1-2; 9:1-6, Ign. Rom. 3:1-2; 6, 3, 1. When these passages are considered, imitation involves suffering and possibly martyrdom. Imitation is also connected to the cross of Christ and is not a means to enforce superiority. Ignatius' view of imitation would contradict the opinions of some scholars who see Paul's injunction for imitation as a claim for power. It also supplies more information to the idea than those who claim that it is simply a counter example to the social situation.

First, it offers new evidence for the rhetorical unity of 2 Cor 2:14-4:6. Second, recognizing the presence of covenant renewal themes in both Paul's epistolary frame and in his midrashic excursus suggests that his opponents in 2 Corinthians were Hellenistic Jewish Christian missionaries. Third, paying attention to Paul's complex portrait of Moses, facilitated by his sequential commentary in the Exodus midrash, provides a window into his confrontation with these missionaries. Although he approves of their use of Moses as a model of Christian transformation, Paul wants to distinguish further between Christian and Hellenistic Jewish versions of this tradition.

Shying away from the more traditional biblical locus used to promote Mosaic exemplarity in Hellenistic Judaism (Exodus 33), Paul focuses on Moses' role as a renewed covenant minister in Exodus 34. Drawing together central theological themes like covenant renewal, priestly tabernacle vision, and particularly parrhēsia, Paul aims to present Moses as both a foil and an exemplar of the Christian apostle, a figure whose glory should be viewed in light of the glory of Jesus Christ.

**Abstract** For the most part, scholars have disregarded the influence of the democratic, civic ekklesiā on Paul's discussion over speech and wisdom in 1 Cor. 1–4. Yet the notion of the civic ekklesiā served as a source of practice, identity and democratic discourse in the early Roman Empire. Moreover, speech proved to be a critical topos of democratic rhetoric, a topos structuring the nature of citizen participation and leadership in the ekklesiā context. Reading 1 Cor. 1–4 in light of ekklesiā discourse provides new insights into Paul's rhetoric as designed to establish his authority by negotiating with a community that understood itself as a powerful, democratic assembly.

**Abstract** I argue that 1 Corinthians is a unified composition that exhibits kerygmatic rhetoric. That is, Jewish and Greco-Roman resources are brought into the service of an overall arrangement that is creatively suggested by Paul's kerygma of the Messiah who died, rose, and awaits cosmic manifestation. In particular, I demonstrate that the Jewish motif of dual reversal, whereby boastful rulers are destined for destruction while righteous sufferers are destined for vindication, serves as an influential conceptual motif in the formulation of Christian kerygma, and as such may be seen as an interpretative framework and rhetorical resource available to Paul. In 1 Corinthians 1-4 Paul evaluates struggles over leadership in the Corinthian congregation as an implicit expression of human autonomy, and responds by summoning the Corinthians to identify with Christ, by forgoing the role of the boastful ruler and adopting the role of the cruciform sufferer. This identification with the cruciform Christ consequently gives shape to Paul's ethical instruction in 1 Corinthians 5-14, a section that draws on Jewish and Greco-Roman resources, while exhibiting a pattern of Pauline ethical argumentation expressive of Paul's kerygma of identification with the embodied Christ. In the final chapter of the main body of the letter (1 Corinthians 15), Paul utilises the Corinthian denial of "the resurrection of the dead" as the ultimate paradigm of their refusal to adopt a cruciform orientation, and urges that the dead in Christ will be raised to immortal glory, while present powers will be brought to nothing. I suggest that this attention to the creative influence of Paul's kerygma on the form of his argumentation represents an important addition to the tools of the Pauline rhetorical analyst. Such an approach results in an historically attentive and exegetically persuasive account of the letter's arrangement that also finds great harmony with the perspective of the fourth century preacher John Chrysostom.

**Abstract** This thesis examines what happens if Paul's directives to married and single persons in 1 Corinthians 7 are read in light of Corinth's Roman cultural context. It seeks to make analogical comparisons between Paul's directives in 1 Corinthians 7 and the Augustan Marriage Laws known as the Lex Iulia and Lex Papia Poppaea. When Paul's directives are read with the Augustan marriage laws, a very complex picture of Paul develops. First of all, against "empire-critical" readers of Paul, the apostle is not entirely against all aspects of the Roman empire. Instead, this thesis demonstrates that as a colonized individual himself, Paul was a "hybrid" figure, who simultaneously borrowed from and fought against many of the ideas of Roman imperialism. Second, this work shows that when Paul disagreed with the Augustan marriage legislation, he did so mainly with respect to what it had to say about widows. In fact, Paul's directives to widows are very similar to the thoughts of many other Roman moralists in the first-century CE. Thus, when Paul addresses widows he is standing on the side of the Roman people over and against Augustus' legislation. As this work comes to a close it explores how Augustus and Paul clothed their moral ideas in apocalyptic discourse. Additionally, it suggests that what Paul and Augustus have most in common is that many of their moral ideas failed to produce any results. For Paul his voice was updated and changed by the writers of the Deutero-Pauline epistles and the Pastoral epistles; for Augustus his voice was muted and refined by later Roman jurists. These types of insights are meant to provide a "redescription" of Paul and the Corinthians to further develop future readings of Paul and 1 Corinthians 7.

<b>Abstract</b>	István Czachesz adapts Mark Granovetter's Social Network Analysis (SNA) view, "the strength of weak ties," that new, innovative information spreads through a network, not through one's intimate family and friends ("strong ties"), but through more distant, hardly known acquaintances ("weak ties"); Paul, constantly on the move, did not make many strong ties, but spread his message through weak ties. This article appreciates, but counterbalances, Czachesz's thesis with the SNA theory that strong ties are necessary for reinforcing risky behavioral change (complex contagions) and with conclusions about recruitment to, and spread of, new religions. It draws attention to Paul's longer stays as an artisan and the kinds of spaces in which he might have stayed. **Abstract** The Pauline call to imitation is one of the most distinctive aspects of Pauline thought. The explicit call to imitation occurs five times in the non-disputed Pauline letters: 1 Thess 1:6; 2:14; 1 Cor 4:16; 11:1; and Phil 3:17. It is a call to imitate the example that Paul sets before the community to which he writes. Although these letters are the only ones in which Paul explicitly calls others to imitate him, the theme of imitation occurs throughout his writings. The monographs and articles that have addressed the theme of imitation in Pauline thought use either the historical-critical method or a rhetorical method to develop their thesis. This study examines the rhetorical function of the theme of imitation in its epistolary context. The rhetorical situation of the community to which Paul writes is an important element in the study of his letters. Therefore, examining each call to imitation within the rhetorical situation of the community to which Paul writes provides a clear understanding of his call to imitation. Although each call to imitation is found within a different rhetorical situation, this study argues that with each call to imitate him, Paul establishes a new set of community relationships to which each believing community must adhere. Within this new set of relationships there are four themes that are crucial to Paul's call to imitation: humility, suffering, unity, and salvation. These four themes form the shape and structure of true community life. Paul's call to imitation and his desire to create this new set of community relationships requires believers to live in humility and to be willing to endure suffering. The purpose of this imitation is to create unity within the community so that at the parousia all believers will share in salvation. Through his own example and the example of Christ, Paul demonstrates the example he calls others to imitate.

**Abstract** When Paul asks for the incestuous man at Corinth to be handed over to Satan is he calling for mere physical expulsion from the community or is he calling for something more?
